HISTORY 494: #Heartlandia: Digital Histories of the Midwest – conditionally **approved** pending removal of the crosslisting to the graduate version & editing the course description for length.

HISTORY 5579 : Public History Theory and Method—conditionally **approved** pending addition of syllabus components & grading criteria

HISTORY 5594: Public History and New Media – conditionally **approved** pending addition of syllabus components & grading criteria

Course Modifications*

COMM-ST 110: Fundamentals Of Effective Speaking And Listening –cmte discussed this extensively, but finally decided that COMM-ST110 was **not approved** as a focus course. A variety of options were suggested as alternatives.

ENV-DSN 110: The Meaning Of Architecture – conditionally approved pending revision of the course description

ART-HIST 315: Arts Of African and New World Cultures (cross-listed with BLKS 315) - tabled

BLKS 315: The Arts of African and New World Culture (cross-listed with ART-HIST 315) tabled

Other Action Items

- Need to elect an A&S Budget Committee representative Liana Sega was elected as our representative
- Need to vote on whether students coming to the CAS with a Bachelor's Degree would automatically meet the CAS degree requirements - tabled
 - Background from Becky: A decision was made by the university that all UMKC Core requirements will be considered met, if a student has a previous bachelor's degree. Does A&S want to consider making the same rule for the CAS degree requirements for second-degree seeking students (with the exception of the Constitution requirement outlined below)?
 - It seemed a sense of the cmte that the suggested policy was too permissive. Becky offered to consider other alternatives in this vein.
- Need to update language in catalog regarding AA degrees from KS approved
 - Background from Becky: It was decided that Associate of Arts degrees from Kansas schools will be honored as Associate of Arts degrees from Missouri have been honored (through the MO statewide agreement).
- Need to update language in catalog regarding Constitution Requirement -approved
 - Background from Becky: It was decided that all students need the Constitution requirement (if they
 haven't taken an equivalent course previously), whether they earn the Associate of Arts prior to transfer
 to UMKC or not. Currently, our language about remaining requirements for students coming in with the
 Associate of Arts has no mention of the Constitution requirement.
